Aloe vera dices in syrup produced from fresh leaves of *Aloe barbadensis M.* (Aloe Vera) from ORGANIC Certified Crops and with sugar.

Product cultivated and processed in our IASC, Organic and IFS certified factory in Valladolid (Spain).

Process description: The leaves of Aloe Vera come fresh in our facilities, where once washed; they are peeled obtaining peeled Aloe Vera. They are cut into dices, washed and packaged together with the water with organic sugar as a governing liquid. The process ends with an autoclave of the product.
